Step 1

Access TSA Data Reporting

Step 2

Logging in

Enter your username and password

- If you have forgotten your password, click on 'I've Lost My Password' to reset (refer to page 6 for more information) or contact GetOnBoard@tyrestewardship.org.au for support.

Step 3

Select unit of measure

Once you are logged in, check that the **Unit of Measure** is preset to your preferred method of reporting (Units or Tonnes).

- For Collectors, you will need to toggle between Units or Tonnes. Light green indicates your selection
- For Recyclers, preset is Tonnes

i.e.: You are not able to report units for CAR tyres and tonnes for SOLID in the same transaction.

Step 4

Select your input/output destination or material

INPUTS

Use the 'Name or ABN button to search and find your accredited TSA partner to add the number of EOLT collected under the 'Type' applicable

- If your supply chain partner is not accredited with TSA, we would love to know who they are and get them onboard

OUTPUTS

As with Inputs use the 'Name or ABN' to search for your accredited TSA Partner or Disposal Material Type

- For Recyclers - TSA will provide guidance on how outputs should be reported according to your audit report, types of tyres handled and end markets. This will occur during the onboarding process.
- For Collectors – Outputs are to accredited TSA Recyclers, search and find your supply chain partner to enter disposals. If your partner is not in the list, notify GetOnBoard@tyrestewardship.org.au

Step 5

Data Entry

Enter the number of tyres you have collected or received against the appropriate tyre category.

If you are reporting in tonnes, please use decimal places to indicate tonnes (e.g. 1 tonne = 1.000) (vs. units reported as integers)

INPUTS – Place your cursor in the ‘Name or ABN’ search field (*as shown*) and start typing the name of your partner to select from TSA database. If found, enter the total weight of tyres collected against the entity under the appropriate tyre category.

Alternatively, you may consolidate your collections by tyre type and report the total for each tyre type. This is done using a generic input code called ‘AdminRetailer’.



Tyre category acronyms

- CAR** – Standard passenger car / van tyre
- LTRV** – Light Truck RV (Includes 4WD)
- TBS** – Truck & Bus Small (17.5" & 19.5")
- TBL** – Truck & Bus Large (20" & 22.5")
- BAL** – Baled (generally not applicable to retailers)
- SHD** – Shred (generally not applicable to retailers)
- MC** – Motorcycle
- SOL** – Solid (miscellaneous tyre types such as bobcat, mower etc).

Data Entry

OUTPUTS

For Collectors -

- Search and find your TSA accredited recycler. This may include multiple company's which you can enter as separate line items.
- Enter quantity of Units or Tonnes against the appropriate tyre type.
- Click on SUBMIT DATA to update the record (located top right).

For Recyclers -

- find your 'end material' using the 'Name or ABN' Search
- Enter the total tonnes against appropriate category
(further guidance will be provided during your onboarding and training).
- Click on SUBMIT DATA button located at top of page


